- 1. Discussion of proposed budget
 - a. 91 paid members

 - c. Grade Boat Club Donation of \$100 and then won raffle for \$100 so evened out
 - d. December 9 mo CD comes due, 22 mo CD due February 2025
- 2. Approval of budget
 - a. Chad moves to approve, Dean H Seconds- Motion passes

IV. Standing Agenda Items

- 1. Boat launch:
 - a. Reminders of Use/parking
 - i. Be cognitive and respectful- try to back in to ensure have more room can park on road
 - b. Porta Potty added to launch
 - i. Gypsy Moths "took over" so need to clean-volunteers to pressure wash etc
 - ii. Do not throw plastic bags/trash in the porta-potty: can result in Fines when pumped
 - c. Key Reminder new keys available please see Ed or Chad for keys
 - d. Rock added at launch on sides of concrete
 - e. Debris from storms continually cleared up
 - f. Gravel approved last year but Ron and Roland were able to move some of existing gravel around
 - i. Whenever need to add gravel its existing in budget
 - g. Greg/Rick S installed pier
 - h. Replacement of concrete on launch- high water so not sure if crack worsened
 - i. May be issue when water lower
 - ii. Bottom half boat launch planks- could replace single plank or whole thing
 - iii. Agree to reach out for a quote, if members see issues raise to board later in season and we can approve
- 2. Park improvements:

- a. Upper Park
 - i. Fire pit done, firewood stacked for use
 - ii. Horseshoe pit-still in the works to install
 - iii. Still looking into sign at upper park- will be Baumgartner park
- b. Lower Park
 - i. Dean B volunteered to stain park in lieu of dues
 - ii. New Basketball hoop still needed backboard/rim/net
 - iii. Suggest Pickle-ball net add to the basketball concrete
 - 1. Get another deck box for storage
- c. Overall- Need bids for re-landscaping for Allan Park and Boat Launch- not mulch
 - i. Weed-mat and stone
 - ii. Volunteers requested- Rick
- 3. Walking path improvements:
 - a. Rock has washed away
 - b. Will need to look at getting more rock in the fall
- 4. Covenant and Bylaw reminders and discussion:
 - a. Covenants are posted online at "MWHA.info"
 - i. Bylaws are filed on all lots with courthouse so changing bylaws are difficult but whether we want to enforce different things is another matter
 - ii. Modifications (such as garage parameters) can stand up in court of law as long as we have a quorum agreement documented
 - iii. Questions- are the homeowners responsible to the blacktop/shoulders of their property- 33 feet from the center-line both sides is owned by the county. Can call them and will add to the list but may take a while
